

The Pharmaceutical Microbiology Forum (PMF) is a not-for-profit scientific and educational organization founded in 1992 to provide a forum for microbiologists involved in the pharmaceutical, medical device, personal product, biotechnology, cosmetic, and related microbiology laboratory areas to exchange information on microbiological issues. The PMF also provides an opportunity to interact with regulatory agencies internationally.

The PMF moderated the industry respected **PMFList** for the microbiology community for many years. The PMFList service first began in 1996 and grew to be an invaluable resource to microbiologists around the world with well over 3000 subscribers from over 70 countries. Subscribers included independent consultants, junior through senior microbiologists and other scientists, along with junior managers up to CEOs with companies including small contract facilities up through major generic and pioneer corporations. This List was replaced with a more modern, reliable, and responsive online forum in February of 2024, and has attracted a vast increase in participants due to its open forum design who accompany the existing subscriber base. New content has been added to the PMF website at http://microbiologyforum.org, thanks to our sponsors. The new FDA Regulatory Actions, Updates to Compendia (proposed revisions as shown in the BP, EP, IP, JP and USP forums) and Articles/White Papers were found to be especially valuable in recent feedback from the List (now the online forum) subscribers.

A conversation was held on the List (now the online forum) regarding its value in the community. We received an incredible number of favorable comments, including those listed below:
